

Criminal Background Checks

Board-by-Board Overview

- 62 state medical boards conduct criminal background checks as a condition of initial licensure
 - 59 state medical boards require fingerprints as a condition of initial licensure
 - 60 state medical boards have access to the Federal Bureau of Investigation database
